E RAWAH RANCH

RAWAH RANCH POLICIES | Please familiarize yourself with the following ranch policies created for your safety and enjoyment.

General Ranch & Facility Rules:

- 1. The Lodge and Saloon (Game Room) are open daily between 7:30am and 10pm.
- 2. The Hot Tub is open between 9am and 10pm; after 6pm, the Hot Tub is closed to children ages 16 and younger.
- 3. Please do not jump in the river and then immediately enter the Hot Tub. Doing so will result in a required 48-hour cleaning period. If you want to jump in the river, please use the shower in the Hideout to rinse off before entering the Hot Tub.
- 4. Please do not stream music or videos on Lodge WIFI due to limited bandwidth and data.
- 5. For safety and insurance reasons, overnight guests must be 18 years or older, or accompanied by an adult. No children 17 years or younger are permitted to stay in unit/cabin unsupervised.
- 6. Personal vehicles may only be parked in the guest parking lot or designated parking spaces.
- 7. Fireworks or explosives of any kind are not permitted on ranch property.
- 8. Personal firearms or weapons of any kind are not permitted on ranch property except as is legally permissible according to Colorado State Concealed Handgun Permit (CHP) statutes.
- 9. Ranch dogs, or animals of any kind, are not allowed in guest cabins or the Lodge.
- 10. Smoking tobacco is not permitted in the cabins, on the porches of cabins, in or around the Lodge, but is allowed in the designated smoking area only in the rocks surrounding the firepit near the Lodge.
- 11. Drugs or narcotics of any kind or legal status are not permitted on ranch property.
- 12. Guests may bring personal alcoholic beverages to consume in their cabins, or around campfires. For licensing reasons, guests may not consumer personal alcohol in the Saloon or Lodge.
- 13. At all times, guests must be accompanied by a ranch Activities Guide while at the shooting range.
- 14. Angler's Package upgrades, including a single additional day of guided fly fishing, must be cancelled more than 24 hours prior to the scheduled service, or guests will be charged in full.
- 15. Massage services must be cancelled more than 24 hours prior to the scheduled service, or guests will be charged in full.

Golf Cart Rules:

- 1. For safety and insurance reasons, you must have a driving permit or license to operate the golf carts on ranch property.
- 2. Do not drive the golf carts behind or near horses at any time. If riders are mounted, or horses are tied at the barn, park the carts and wait for the horses to pass, or find an alternative route. Driving carts in proximity to the horses may spook them and lead to injury to riders or observers.
- 3. For your safety and others at the ranch, please do not drive the carts while intoxicated. You may ask a staff member to escort you to your cabin.
- 4. Please do not cross water in the golf carts. They are electric and will be ruined if submerged.
- 5. In order to keep the ranch looking nice, please do not park the golf carts in the lawn, but rather in the appropriate parking areas.

H RAWAH RANCH

Barn & Horseback Riding Rules:

- 1. All riders must attend Rawah's Riding Orientation prior to their first ride. **During orientation**, wranglers may establish addition rules or guidelines that guests are expected to abide by, whether written or verbal.
- 1. All guests must complete one preliminary walking ride prior to participating in advanced rides, regardless of age or experience level.
- 2. At no time are guests permitted behind the barn gates.
- 3. Guests must use the mounting block to get on their horse, regardless of skill level.
- 4. Cowboy boots are required for riding. No tennis shoes or lug-soled shoes permitted.
- 5. If wearing a hat while riding, guests must use stampede strings to secure hats from blowing away.
- 6. Everyone under the age of 18 must wear a helmet, without exception.
- 7. Guests 18 years and older who do not wish to wear a helmet must sign a helmet waiver.
- 8. Children under the age of 5 are not permitted to ride horses.
- 9. All children under 10 must be approved by a wrangler in order to accompany adults on a trail ride.
- 10. Wranglers hold total discretion to determine whether guests of any age or experience level may participate in riding activities.
- 11. The ranch will not host any rides if active lightning is observed within 10 miles of ranch trails.

Fly Fishing & River Rules:

- 1. For licensing reasons, guests must be accompanied by a ranch Activities Guide while fly fishing on ranch property at any point, regardless of individual skill level or use of personal equipment.
- 2. If guests bring their own fishing equipment, it must be checked in at the fishing shed each evening during their stay.
- 3. Fishermen under the age of 10 are permitted to fish from the Rawah Pond.
- 4. Guests aged 11 and older must be approved by a fishing guide to fish the river.
- 5. It is the responsibility of each guest to obtain a CO State Fishing License if he/she intends to fish off site at any point.

Safety Guidelines:

1. It is recommended that all guests who decide to go on a hike without a guide please check-out a walkie-talkie and map at the front desk prior to departure.
